
There are 927,282 children ages 5 and under in Illinois.

While 67% of children ages 5 and under live in households in which all parents work, 18% of all children in this age group live in families below the poverty line (\$21,960).¹






Quality early care and learning programs contribute to both thriving economies and healthy families.


In 2020, there were 15,030 child care workers in Illinois. This is a 9% decline in the number of child care workers from 2019 and a 13% decline since 2016. In 2020, the annual mean salary for child care workers was \$27,230.¹⁶ In Illinois, 41% of young children do not have access to formal child care.



Number of Child Care Workers: 5-Year Trend¹⁷




Child Care Worker Annual Salary (2019) \$27,230^{18, 19}



Child Care Supply Gap²³

In Illinois, 617,420 children have the potential need for child care. There is a supply of 364,210 child care slots. The families of 253,210 children do not have access to child care. The child care gap is 41.2% of the potential need (children with working parents).


