
There are 687,140 children ages 5 and under in Michigan.

While 64% of children ages 5 and under live in households in which all parents work, 21% of all children in this age group live in families below the poverty line (\$21,960).¹





Child Care Funding


Quality early care and learning programs contribute to both thriving economies and healthy families.

Child Care Providers


In 2020, there were 15,730 child care workers in Michigan. This is a 9% decline in the number of child care workers from 2019 and a 7% decline since 2016. In 2020, the annual mean salary for child care workers was \$25,580.¹⁶ In Michigan, 30% of young children do not have access to formal child care.



Number of Child Care Workers: 5-Year Trend¹⁷




Child Care Worker Annual Salary (2019) \$25,580^{18,19}



Child Care Supply Gap²³

In Michigan, 439,040 children have the potential need for child care. There is a supply of 307,890 child care slots. The families of 131,150 children do not have access to child care. The child care gap is 30.2% of the potential need (children with working parents).


