EXECUTIVE SUMMARY

- 1. Hispanic parents value cultural education for their children, however, it is not a top factor when selecting a child care provider. A majority of Hispanic parents say it is important for their child care provider to incorporate Latino culture in their child care (58% saying it is *essential* or *important but not critical*). At the same time, a child care provider *not* offering culturally relevant teachings or activities doesn't negatively impact Hispanic parents' likelihood to consider that arrangement. Across different measures, data shows those currently using a formal arrangement place *more importance* on cultural education.
- 2. Trust in the child care provider is the most important factor when selecting a child care arrangement. Trust in the child care provider is nearly 4 times more important than the average variable. On the other hand, bilingual educational opportunities, providers who look like their family, or share the same cultural background as their family are the least important factors. Of a smaller list, Hispanic parents express similar sentiments- placing the highest importance on cost of care and school readiness over location, faith-based teaching, cultural values, and being Spanish-speaking. Among Hispanic parents currently using relatives for child care, a majority (77%) report grandparents are providing care, and express they value trusting their relatives for child care (48%), while only 13% say financial necessity.
- 3. Consistent with previous data sets, Hispanic parents prefer the child care arrangement they are currently using even if a child care arrangement was free and in a convenient location. Among those using a formal child care arrangement, 73% would prefer a formal arrangement, and among those using an informal arrangement 67% would prefer this child care even if it was free and in a convenient location. Location and cost are key for Hispanic parents currently using an informal child care arrangement to be likely to consider a formal option.
- 4. Child care responsibilities impact Hispanic parents' ability to work, and an unpredictable work schedule may impact their child care arrangement. Nearly half of Hispanic parents (47%) say their child care responsibilities have impacted their ability to work at least *sometimes* over the past month. Similar to previous data sets, over half of Hispanic parents who are service/retail workers (54%) are aware of their work schedule 2 weeks in advance or less. Additionally, among Hispanic parents currently using relative child care, 51% are aware of their schedule 2 weeks in advance or less, compared to 40% of those in a formal child care arrangement.


GENERATIONAL DIFFERENCES

Analyzing Survey Results Across Generational Status

- 1. Current Child Care Arrangement Hispanic parents who are second (17%) and third (20%) generations are more likely than first generation (12%) to currently be relying on relatives for their child care arrangement. On the other hand, Hispanic parents who are first-generation are more likely to be using parent-provided child care. Lastly, second-generation Hispanic parents are more likely than other generations to currently be using a child care center.
- 2. Child Care Preferences- Similarly, Hispanic parents preferred child care arrangement reflects their current arrangement, and varies across generation. Third generation Hispanic parents are most likely to prefer relative care (22%), second generation is split between preferring a head start program (18%), child care center (15%), and their partner providing care (14%), and first generation is split between preferring a child care center (18%), relative care (17%), a head start program (15%), and their partner providing care (15%).
- 3. Important Factors of Child Care- Across generation type the three most important variables of a child care provider remain the same (trust, safety/cleanliness/prevention of illness, and quality caregivers). However, those from a third-generation family are especially likely to value trust in the provider.

4. Value of Latino Culture – On the measures of the importance of child care providers teaching Latino culture, there are some difference between third generation parents and first and second generation. For example, a majority of Hispanic parents of first (63%) and second-generation (62%) say it is important for their child care provider to incorporate Latino culture in their child care, compared to 49% of third-generation Hispanic parents who say the same.

Which of the following best describes your generational status in the U.S.?




COMMUNITY TYPE DIFFERENCES

Analyzing Survey Results Across Community Type

- Current Child Care Arrangement Urban parents are more likely than suburban and rural parents to be currently using a formal child care arrangement, specifically a child care center. On the other hand, rural parents are more likely to rely on parent provided care for a child care arrangement.
- 2. Distance to Child Care- Hispanic parents living in a rural community (31%) are less likely than those in urban (38%) or suburban (45%) areas to have a child care program less than 5 miles from their home.
- Child Care Preferences- If child care were free and in a convenient location, relatives are a preferred provider across community type (urban 18%, suburban 15%, rural 17%). Urban (16%) and suburban (14%) Hispanic parents are much more likely than rural parents (4%) to prefer a child care center.
- 4. Important Factors of Child Care- Across community types trust, safety/cleanliness, and quality caregivers are the most important factors when selecting a child care provider, although trust is especially important to rural Hispanic parents.

BACKGROUND

The research conducted by Morning Consult on behalf of the Bipartisan Policy Center sought to understand employed Hispanic parents' current child care arrangements and preferences, specifically the importance placed on cultural values. Additionally, advanced analysis was used to understand the trade-off parents are prioritizing when selecting a child care provider.

AUDIENCE

Employed Hispanic parents were screened on having a child ages 0-5 and at leas one parent in the household being currently employed. For simplicity, this audience is referred to as **Hispanic parents**.


METHODOLOGY

This poll was conducted between December 7-15, 2023, among a national sample of n=523 Hispanic parents. The interviews were conducted online and data were weighted to approximate a target sample of Hispanic parents based on age, gender, education level, and region. Results from the full parent survey have a margin of error of plus or minus 4 percentage points. The survey was translated to Spanish and respondents had the option to take the survey in English or Spanish.



CURRENT CHILD CARE ARRANGEMENT

Hispanic parents are most likely to need child care during traditional work hours (78%), however over a third need care over the weekends (37%) or outside of traditional work hours (35%).

A child care arrangement can include centers, home-based child care, pre-k, relatives, parents, etc. In a typical week, does your family need a child care arrangement for your children under 5 so that you (or both you and your spouse/partner) can work during the following hours?



Hispanic parents who work in the service/retail industry are especially likely to need child care over the weekends (45%) and outside of traditional work hours (44%).

• Additionally, Hispanic parents who use a formal child care provider (90%) are more likely than those who use informal child care (68%) to need child care during traditional hours. This data point shows formal child care providers are best suited to meet childcare needs during traditional work hours.



CURRENT CHILD CARE ARRANGEMENT

Half of Hispanic parents rely on informal child care (54%), with 17% using relative care and 34% using some form of parent-provided care. On the other hand, 43% use a formal child care arrangement.



Similarly in close-ended questions, health and safety (49%), trust (46%), and program cost (37%) are the most important factors. Ranked lowest on the list of factors is cultural compatibility (8%).



Which of the following best describes why you rely on relatives for child care? *Among those currently using relative care, n=88*





MAXDIFF ANALYSIS

Maximum Difference Scaling (Max-Diff) is a discrete choice methodology which asks respondents to make a **series of forced choice responses about a larger list of like-type variables**.

Through an experimental design and implementation we are able to mathematically assess the rank-ordering of these variables and, perhaps most importantly, assess the relative preference for each option.

Max-Diff data collection and analysis method is used to measure respondents' relative preferences for differing alternatives. Max-Diff measures statements competitively in a series of sets rather than individually in a list. This allows us to see trends in individual respondent preferences and determine which items are truly more vs. less important by forcing trade-offs.

Respondents were asked to rank the importance of a set of 15 factors when thinking about the child care provider for their youngest child.












How important is it to you, if at all, that your child care provider incorporates Latino cultural practices, traditions, or values into their care for your child?


A child care provider *not* offering culturally relevant teachings or activities doesn't negatively impact Hispanic parents' likelihood to consider that arrangement.





Thinking about your work hours, how far in advance are you aware of your work schedule, or do you have a fixed work schedule?






How many children under the age of 5 do you have?



Which of the following best describes your generational status in the U.S.?




What best describes your cultural background?


