





# 10 Things to Know About California's Child Care Workforce

Forty-six child care workforce registries across the country collect comprehensive data on their state's workforce. This report is a first-of-its-kind snapshot of child care workforce data collected by registries across the country. This is just a small slice of the capabilities of registries, many of which collect data to even greater levels of detail.


#### CALIFORNIA'S DATA

The data included here is from the California Early Care and Workforce Registry as of September 30, 2023. The data includes those who work in programs participating in Quality Counts California, locally driven initiatives, and Workforce Pathway stipends. Participation in the registry for all other workforce members is voluntary. California's registry has a total of 156,000 active user profiles. This report reflects 125,454 active users working in direct care positions, inclusive of trainers and coaches. <u>California's</u> <u>registry profile sheet</u>.



**4** Employment Status<sup>2</sup>




#### **5**. Gender<sup>3</sup>
