







10 Things to Know About the District of Columbia's Child Care Workforce


Forty-six child care workforce registries across the country collect comprehensive data on their state's workforce. This report is a first-of-its-kind snapshot of child care workforce data collected by registries across the country. This is just a small slice of the capabilities of registries, many of which collect data to even greater levels of detail.

DISTRICT OF COLUMBIA'S DATA

The data included here is from the District of Columbia Division of Early Learning Licensing Tool as of October, 2023. The data includes those who work in programs participating in Capital Quality, which includes all licensed child development facilities. Participation in the registry for all other workforce members is voluntary. DC's registry has a total of 8,033 active user profiles. This report reflects 3,904 active users working in direct care positions. District of Columbia's registry profile sheet.






