





10 Things to Know About Georgia's Child Care Workforce

Forty-six child care workforce registries across the country collect comprehensive data on their state's workforce. This report is a first-of-its-kind snapshot of child care workforce data collected by registries across the country. This is just a small slice of the capabilities of registries, many of which collect data to even greater levels of detail.


GEORGIA'S DATA

The data included here is from the Georgia Professional Development System as of November 16, 2023. The data includes those who work in programs participating in Quality Rated, Georgia's Pre-K, as well as individuals receiving financial benefits from DECAL Scholars. Participation in the registry for all other workforce members is voluntary. Georgia's workforce registry has a total of 143,350 active user profiles. This report reflects 106,048 active users working in direct care positions.



3. Workforce Age




4 Employment Status
