10 Things to Know About Iowa's Child Care Workforce

Forty-six child care workforce registries across the country collect comprehensive data on their state's workforce. This report is a first-of-its-kind snapshot of child care workforce data collected by registries across the country. This is just a small slice of the capabilities of registries, many of which collect data to even greater levels of detail.

IOWA'S DATA

The data included here is from the 2023 Iowa Child Care Workforce Study published by the Iowa Association for the Education of Young Children and Iowa's Integrated Data System for Decision Making as of May 2023. The data includes a sample of 4,282 employees who participated in the study. Workforce Size data was provided by Iowa's Early Childhood and School Age Professional Workforce Registry (I-PoWeR) and includes those who work in programs regulated by the Iowa Department of Health and Human Services, and approved adult educators. Iowa's registry has 105,618 total active user profiles. This report reflects 22,264 active users working in direct care positions and approved adult educators. <u>Iowa's registry profile sheet</u>.


