







10 Things to Know About Michigan's Child Care Workforce

Forty-six child care workforce registries across the country collect comprehensive data on their state's workforce. This report is a first-of-its-kind snapshot of child care workforce data collected by registries across the country. This is just a small slice of the capabilities of registries, many of which collect data to even greater levels of detail.

MICHIGAN'S DATA

The data included here is from the MiRegistry as of November 30, 2023. The data includes those who work in programs participating in Michigan's Great Start to Quality, Head Start, Universal PreK/VPK, and license-exempt (FFN) providers. Participation in the registry for all other workforce members is voluntary. Michigan's registry has a total of 90,790 active user profiles. This report reflects 39,881 active users working in direct care positions, inclusive of coaches and trainers. Michigan's registry profile sheet.




