







# 10 Things to Know About Nebraska's Child Care Workforce

Forty-six child care workforce registries across the country collect comprehensive data on their state's workforce. This report is a first-of-its-kind snapshot of child care workforce data collected by registries across the country. This is just a small slice of the capabilities of registries, many of which collect data to even greater levels of detail.

#### NEBRASKA'S DATA

The data included here is from the Nebraska Early Childhood Professional Record System as of February 5, 2024. Participation in the registry is required for "Step Up to Quality" QRIS Participating Program's Staff and voluntary for all other workforce members. Nebraska's registry has a total of 20,184 active user profiles. This report reflects 19,433 active users working in direct care positions, inclusive of coaches and trainers. 




