10 Things to Know About Nevada's Child Care Workforce


Forty-six child care workforce registries across the country collect comprehensive data on their state's workforce. This report is a first-of-its-kind snapshot of child care workforce data collected by registries across the country. This is just a small slice of the capabilities of registries, many of which collect data to even greater levels of detail.

NEVADA'S DATA¹

The data included here is from The Nevada Registry as of December 15, 2023. The data includes those who work in programs participating in Silver State Stars QRIS and licensed child care programs. Participation in the registry for all other workforce members is voluntary. Nevada's registry has a total of 8,600 active user profiles. This report reflects the 6,912 active users working in direct care positions, exclusive of coaches and trainers. Nevada's registry profile sheet.




