



10 Things to Know About Rhode Island's Child Care Workforce


Forty-six child care workforce registries across the country collect comprehensive data on their state's workforce. This report is a first-of-its-kind snapshot of child care workforce data collected by registries across the country. This is just a small slice of the capabilities of registries, many of which collect data to even greater levels of detail.

RHODE ISLAND'S DATA

The data included here is from the Rhode Island 2023 Early Childhood Educator Compensation Study. The online web survey was released on October 17, 2023, and ran through November 2023. In addition to sending the survey link to all center-based and family child care providers using the DHS Licensed Providers list, data was also utilized from the Pandemic Retention Bonus initiative to distribute the survey to known individual educators by email and encourage participation. A total of 1,162 educator responses were received as a part of the survey. <u>Rhode Island's registry profile sheet</u>.




