





I0 Things to Know About West Virginia's Child Care Workforce

Forty-six child care workforce registries across the country collect comprehensive data on their state's workforce. This report is a first-of-its-kind snapshot of child care workforce data collected by registries across the country. This is just a small slice of the capabilities of registries, many of which collect data to even greater levels of detail.


WEST VIRGINIA'S DATA

The data includes those who work in licensed child care centers, family child care facilities, family child care homes, and trainers/coaches. Participation in the registry is voluntary for all other Early Childhood workforce members. West Virginia's registry has a total of 10,289 active user profiles. 


