Together with our partners and supporters, we turned ideas into action—and made measurable progress on the issues that matter most to American families.



KEY PROGRAM ACHIEVEMENTS

ECONOMIC POLICY

BPC's Economic Policy Program develops bipartisan policy recommendations to enhance the prosperity and security of the American people and economy. We advance pro-growth, fiscally responsible policies that support business and expand opportunity and financial security for workers, families, and retirees.

Fiscal and tax policy dominates the 2025 legislative calendar, and the work we've done since 2010 sets the stage, creating a key opportunity for BPC's Economic Policy Program. In 2024, BPC and BPC Action pioneered a new approach to responsible fiscal policy education and advocacy. Through a multifaceted campaign, we expanded the conversation on the national debt, reaching advocates and grasstop leaders by connecting the issue to their priorities, including housing affordability, health care, workforce development, and U.S. competitiveness.

Our team was pivotal in advancing responsible fiscal policy and budget process reform, contributing to 17 pieces of legislation introduced or advanced in the 118th Congress. Most recently, we helped drive the reintroduction of the Responsible Budgeting Act to reform the federal debt limit.

BPC's Economic Policy Program also burnished its reputation as a trusted voice on fiscally responsible tax policy. We helped shape the debate around tax reform that will benefit workers, businesses, and the economy by analyzing key tax priorities and offering a range of options for lawmakers seeking to offset the cost of extending the 2017 tax cuts.

Council (ASEC) is dedicated to promoting
the financial well-being of all Americans. Its
membership includes 103 partners across all
sectors. At its spring and fall summits, ASEC
brought together partners and key executive and
legislative branch representatives to discuss
financial and retirement security. These forums
sparked actionable dialogue on policies that support
older workers, financial inclusion, and Social
Security reform.

ENERGY

Affordable, clean, and reliable energy is essential to unlocking the potential of each and every American. BPC's Energy Program is uniquely positioned to advance federal policies to boost our economy, make America more secure, and strengthen the nation's infrastructure—all while keeping the United States a global energy leader. Our work focuses on the urgent need to address increasing energy demand and international competition. Our goal is a modernized energy system that meets the needs of the American people and businesses.

The Energy Program brought together experts and policymakers to advance bipartisan solutions that lower costs, boost reliability, and reduce carbon emissions. BPC has become a leading voice on permitting reform for both Congress and stakeholder organizations. After we published *Finding the Goldilocks Zone for Permitting Reform* in January, several policy options were incorporated into the Senate Energy Permitting Reform Act of 2024, which was voted out of the Senate Energy and Natural Resources Committee on a bipartisan 15-4 vote following a strong push from BPC Action.

Over the past year, the Energy Program has also spotlighted the global demand for critical minerals and materials. Thanks to the strong partnership between BPC and BPC Action, several of our recommendations were reflected in the Fiscal Year 2025 National Defense Authorization Act and other legislation. The Energy Program's Resilient Resource Reserve recommendations helped shape the bipartisan Senate Critical Materials Future Act.

Additionally, BPC's Farm and Forest Carbon Solutions Task Force influenced key provisions in the House Agriculture Committee-reported farm bill and the Senate Agriculture Committee's majority and minority farm bill frameworks.

At BPC's Climate and Trade Capitol Hill Summit in July, featuring seven members of Congress, the Energy Program launched our new Climate and Trade Advisory Council. The council will help guide future research, analysis, and education efforts in this policy arena. In September, BPC's Margaret Spellings spoke with NVIDIA CEO Jensen Huang, marking the launch of a new policy project on AI and energy and the release of our first AI-focused report.

HUMAN CAPITAL

Across the United States, families grapple with the high cost and limited availability of quality child care and increasing caregiving challenges. Students are falling behind in reading and math, graduates are stepping into the world unprepared for the demands of the workplace, and critical gaps persist between workers' skills and the jobs needing to be filled. What's required is a cohesive, national strategy to invest in our greatest asset—our people. BPC's Human Capital Program is tackling this challenge head-on.

Since its launch in 2024, the Human Capital Program has strengthened BPC's leadership in paid family leave, early childhood, and higher education while expanding into K-12 education and workforce development. By working under one umbrella to publish new content, advance recommendations, and engage policymakers, the team refocused attention on the knowledge, skills, and support that workers need to reach their full potential.

In December, BPC formed the Commission on the American Workforce. Co-chaired by former Govs. Bill Haslam (R-TN) and Deval Patrick (D-MA), the 24-member commission is developing a national, bipartisan strategy to strengthen the workforce, expand economic opportunity, and keep the United States globally competitive. Four working groups—elementary and secondary education, postsecondary pathways, workers and the workforce, and worker supports—comprising more than 60 educators, scholars, policymakers, and business and nonprofit executives support this commission. Their work has drawn national interest and will culminate in actionable. bipartisan recommendations for Congress and the Trump administration in 2025.

As national conversations around working families and education gained momentum, the Human Capital Program played a leading role in critical policy debates. Its work to build strong issue champions led to BPC and BPC Action's support of 16 pieces of legislation, including a comprehensive child care reform package led by Sens. Katie Britt (R-AL) and Tim Kaine (D-VA).

"In 2025, the challenge is clear: Child care remains



out of reach for too many working parents, our schools are failing our children, and our workforce development system is falling short of economic demands. As the commission's work progresses, our team is ready to drive long-overdue federal conversations on improving the nation's education and workforce systems. There is no more urgent task, and we are eager to put forward a new talent strategy that promotes prosperity for all Americans."

In the 118th Congress, BPC Action helped bring together a first-of-its-kind, member-led initiative, the bipartisan House Paid Family Leave Working **Group,** to find common ground and develop policy solutions that address pressing national challenges.

In the House, the group is led by Reps. Stephanie Bice (R-OK), Chrissy Houlahan (D-PA), Colin Allred (D-TX), Julia Letlow (R-LA), Mariannette Miller-Meeks (R-IA), and Haley Stevens (D-MI).

BPC and BPC Action supported the launch of a partner working group in the Senate led by Sens. Bill Cassidy (R-LA), Kirsten Gillibrand (D-NY), Maggie Hassan (D-NH), Cynthia Lummis (R-WY), and Thom Tillis (R-NC).

THE J. RONALD TERWILLIGER CENTER FOR HOUSING POLICY

The vision of the Terwilliger Center is an America where every family, regardless of income or background, can live in a decent, safe, and affordable home. To achieve this goal, the Center is working to advance policies that address the severe shortage of affordable housing for both renters and homeowners, while ensuring that America's lowest-income families can obtain the housing assistance they need. As an organization with strong connections across the political spectrum in Congress and in strong partnership with BPC Action, the Center is uniquely positioned to advance on a bipartisan basis both supply-side and demand-side initiatives to improve housing affordability.

Now in its fourth year, the J. Ronald Terwilliger Center for Housing Policy solidified itself as a prominent leader in advancing bold, innovative policies to improve housing affordability. As a convener, educator, and advocate, the Terwilliger Center brings together members of Congress, Cabinet secretaries, governors, mayors, housing professionals, and business leaders to address

the nation's considerable housing challenges. Our signature legislative plan, the *American* Housing Act, demonstrates that a bipartisan, comprehensive approach to increasing the supply of affordable homes, preserving the existing affordable housing stock, and helping low-income families find affordable housing is achievable. The 118th Congress saw the introduction of over 20 pieces of legislation reflecting our recommendations.

With support from BPC Action, the Terwilliger Center has prioritized the supply dimension of the housing affordability crisis, recognizing its bipartisan appeal. This focus has driven meaningful progress, including the potential passage of legislation to strengthen and expand the Low-Income Tax Credit and create a new tax credit to incentivize private investment in homes for sale in distressed communities. In 2024, the Terwilliger Center hosted its third annual Summit on Housing Supply Solutions, its largest inperson and virtual gathering to date, showcasing innovative approaches to increasing the nation's housing supply. The Terwilliger Center has also drawn significant corporate support for its Executive Council for Housing Affordability, underscoring the link between housing affordability, productivity, and economic growth.

Through extensive programming and highquality communications, the Terwilliger Center in 2024 spotlighted critical issues, including successful local efforts to prevent and reduce homelessness, the impact of rising property insurance costs on housing affordability, and the importance of encouraging greater landlord participation in the Housing Choice Voucher program by reforming the inspections process.

Jerry Moran (R-KS), Tina Smith (D-MN), Chris Van Hollen (D-MD), and Todd Young (R-IN), and Reps. Emanuel Cleaver, II (D-MO), Suzan DelBene (D-WA), Brian Fitzpatrick (R-PA), and Mike Kelly (R-PA).

DEMOCRACY

American self-governance depends upon the people's participation and their confidence in the fairness and representativeness of our electorial system. It also requires that elected leaders build relationships to work through partisan differences. BPC's Democracy Program aims to create resilient and fair voting processes, trustworthy and accountable government institutions, and civic-minded and bipartisan leaders. Through these reforms and dialogues, our work helps to build a thriving America powered by a vibrant democracy, effective representative government, and strong communities.

Presidential election years are always busy for BPC's Democracy Program, and 2024 was no exception. We supported election officials working hard to implement our recommended policies while preparing for a new Congress, executive leadership, and state legislators who are eager to move legislation quickly in 2025. This past year, the team led efforts on and off Capitol Hill to build a more effective Congress, provide reliable, accessible elections and voting resources, and organize bipartisan trips with members of Congress to strengthen collaboration. These initiatives reinforce BPC's role as a national leader in shaping a freer, fairer, and more representative democracy.

The Elections Project played a vital role in helping keep elections safe and secure in 2024. We conducted hands-on tabletop exercises in five swing states to simulate threats to elections and "The success of the 2024 elections reflects years of improvements in

provided election administrators with resources on policies and practices to mitigate risk. We also published groundbreaking research on turnover in the elections workforce, setting a new standard for understanding how election administration has changed over the past 20 years.

Following a wave of Supreme Court rulings in summer 2024, BPC formed a working group to help Congress navigate shifting legislative and regulatory dynamics. The group offered practical recommendations to strengthen how lawmakers draft laws and oversee federal agencies.

BPC's American Congressional Exchange is a one-of-a-kind program that pairs members of Congress to travel to each other's districts with the goal of fostering partnerships to advance bipartisan legislation in Washington. In 2024, we facilitated five trips to bring members together, including the first binational trip, which took a bipartisan delegation of six U.S. representatives to and across the southern border.

In December, BPC hosted its biennial Elections Summit, convening nationwide election administrators, academics, and thought leaders to reflect on the 2024 cycle, assess evolving election threats, and discuss ways to strengthen election policy. The event drew a full house, with Sen. Amy Klobuchar (D-MN) and former Sen. Roy Blunt (R-MO) joining a discussion on the future of federal and state election policy.

HEALTH

BPC's Health Program advances bipartisan policy solutions to build a more cost-effective, evidence-based health care system to improve Americans' health. We work to strengthen and sustain Medicare and Medicaid, accelerate the shift toward value, address inefficiencies and misaligned incentives, and responsibly leverage technology and innovation.

In 2024, BPC and BPC Action were pivotal in crafting federal policy on long-term care, behavioral health, and rural health. Our recommendations informed bipartisan Senate legislation to expand integrated care for individuals dually eligible for Medicare and

Medicaid. The House Energy and Commerce Committee unanimously passed, and the Senate introduced, measures reflecting BPC's proposals to make it easier for people with disabilities to work without losing Medicaid coverage. In collaboration with BPC Action, the Health Program also helped shape key provisions in the Senate's year-end package to strengthen the SUPPORT Act, legislation to address the national opioid crisis. Additionally, the Substance Abuse and Mental Health Services Administration adopted a new behavioral health workforce framework—developed with input from BPC—to help states and providers address staffing shortages and ensure continued access to care.

BPC also engaged communities directly through a 20-site rural health tour across Nebraska. Minnesota, and South Dakota—designed to inform BPC's continued work on behavioral health, rural hospital sustainability, and digital health solutions. The tour culminated in a private roundtable with rural hospital associations and experts in Sioux Falls, SD.

In 2024, BPC's Health Program undertook three major initiatives. The Youth Mental Health and Substance Use Task Force—led by former Gov. Steve Beshear (D-KY), former Rep. and Gov. John Kasich (R-OH), and former Reps. Val Demings (D-FL) and Jaime Herrera Beutler (R-WA)—released

Another member-led initiative in 2024 was the Youth Mental Health and Substance Use Honorary Congressional Working Group—Sens. Katie Britt (R-AL), Tina Smith (D-MN), and Dan Sullivan (R-AK) and Reps. Lisa McClain (R-MI) and Brittany Pettersen (D-CO)—which underscored the need for bipartisan collaboration in addressing mental health crises.

its first report on youth behavioral health, alongside a national survey highlighting urgent policy needs. BPC also launched an initiative to shape bipartisan, evidence-based AI policy, equipping congressional and administration staff with reliable insights on AI's role in health care. Finally, BPC helped relaunch the House Congressional Primary Care Caucus, bringing renewed attention to the nation's primary care crisis and the need for stronger policy solutions.

BIPARTISAN POLICY CENTER'S AMERICAN

BRIDGING DIVIDES AND BUILDING SOLUTIONS

The American Congressional Exchange (ACE) brings members of Congress to each other's districts to build relationships and find common ground that supports bipartisan policymaking in Washington. The program is transforming how lawmakers connect, collaborate, and develop bipartisan solutions.

BPC designs strategic and impactful itineraries that showcase the uniqueness of each district

while diving deep into the policies and issues affecting Americans. Itineraries often include visits to major employers like hospitals and universities, key leaders in business like Boeing, Ford Motor, and Walmart, and conversations with local lawmakers, faith leaders, and constituents.

From bolstering mental health and veterans' resources, advancing a responsible fiscal policy agenda, to combating the scourge of addiction,



CONGRESSIONAL EXCHANGE (ACE)

ACE alums in Congress have worked together to introduce and pass bipartisan legislation addressing the most pressing issues for Americans.

In today's partisan environment, it is more important than ever to create time for members of Congress to develop authentic, lasting relationships with their colleagues across the aisle. The ACE program can bridge divides,

amplify unheard voices in underserved communities, and pave the way for a more collaborative and effective government.

BPC has conducted ACE trips since 2018 with 64 members from 27 states, many of whom had no prior relationship, but came back to Washington and collaborated to introduce dozens of bills and to pass four.




